Under the 'The Work Will Involve' subheading – all bullet points need to start with capital letter and remove all semi colons from end of bullet points.

Under the 'Pricing for work done in relation to applications for leave to remain:' subheading:

Fourth paragraph missing a space after comma: "witnesses,possible attendance"

RESIDENTIAL CONVEYANCING

Put all the bold subheadings on this page in capital letters to match rest of the pages.

Under the 'Disbursements' subheading there is a space needed after "smoother process.There".

Under the 'Our estimated fees assume that' subheading, all bullet points should start with capital letters.

PRICING FOR MOTORING OFFENCES

Under the 'THE WORK THAT WILL BE UNDERTAKEN WILL INCLUDE:' subheading, all bullet points should start with capital letters. The same for bullet points under the subheading 'FEE INCLUDES' and those directly after.

PROBATE PRICING

All subheadings in bold should be in capital letters.

Under the 'Probate, applying for the grant' subheading:

First Paragraph: Space needed between "We have an", after the full stop "fee quote. Our" and "experience) The exact".

A line space needed between subheading "This estimate is for estates where:" and the first bullet point.

Under the 'Disbursements' subheading:

Bullet point missing for the point: £7.00 to £10.00 Swearing of the oath (per executor).

Remove all full stops from the end of each bullet point.

PERSONAL INJURY COMPENSATION

Sentence rewritten:

Second Paragraph: We understand that you would like to know the amount of compensation you are entitled to but due to the fact that each case is treated distinctly – the exact amount can only be given by our experts after analysing your claim.

Sentences rewritten:

Sentences rewritten:

Third Paragraph: Our Corporate Law team have developed strong and long term relationships with clients over many years. A large percentage of our clients from our clients list would recommend our services to other corporations, friends and family.

HOUSING DISREPAIR – should be in capital letters.

INSOLVENCY & BANKRUPTCY

Sentences rewritten:

First Paragraph: We also specialise in bringing winding up petitions against companies.

Make sure all bullet points under 'Bankruptcy Areas' subheading start with capital letters.

PERSONAL INJURY

Sentence rewritten:

First paragraph: If you have had an accident in the last 3 years, such as slip & trip or an injury at work, then do not allow your claim to go to waste and come to Law Lane Solicitors.

PROFESSIONAL NEGLIGENCE

All bullet points should start with capital letters.

FAMILY LAW

Sentences rewritten:

First paragraph: Law Lane Solicitors handles almost all types of family cases.

CAVITY WALL

Delete repeated subheading 'Potential signs of Cavity Wall Issues'.

Sentences rewritten:

Under the 'Investor and Entrepreneur Visa' subheading:
